All the District Educational Officers and ex-officio Project Coordinator, SS and Additional Project Coordinator, SS in the state are informed that some of the DEOs/APCs have submitted representations with a request to seeking clarifications on continuation of erstwhile roaster points and newly formed districts.

- a. In this regard, the following clarification is issued in regard to taken up recruitment the districts.
- b. Fresh roaster can be started in the newly formed districts for the filling up of posts both teaching and non-teaching of district level posts.
- c. The existing roasters points can be continued in the erstwhile

districts.

- d. Regard to mandal level posts a separate fresh roaster can be started for every post.
- e. The applications of the districts of Dr.B R Ambedkar Konaseema and Kakinada district shall be considered in Erstwhile East Godavari District.
- f. The applications of West Godavari and Eluru district shall be considered in the erstwhile west Godavari District.
- g. The applications of Palandu and Guntur district shall be considered in erstwhile Guntur District.
- h. The applications of Krishna and NTR district shall be considered in erstwhile Krishna District.
- i. However, the recruitment in respect of erstwhile East Godavari shall be taken up by DEO/ APC, Kakinada, in respect of Erstwhile West Godavari shall be taken by DEO/ APC, Eluru, in respect of Erstwhile Guntur shall be taken by DEO/ APC, Palnadu and in respect of erstwhile krishna the recruitment shall be taken up by the DEO/ APC, NTR District.
